Adoption of Minutes: August 1, 2018 – APPROVED with no correction. • Agenda Item 1 – CCAE as Professional Development: this year the conference will be held in San Diego. It's a good professional development opportunity for consortium members to attend. Conference registration and event details will come out shortly. What about getting a purchase order to cover expenses for members attending instead of a cash advance? The Consortium budget would pay. The implementation team will look at different options and bring them back to advisory committee members. • Agenda Item 2 – End of the Year Deliverables: new deliverable due September 30, 2018. AEP expenditures by program area, this year each member needs to add up expenditure by object. Need to figure out a formula to match expenditure to object. • Agenda Item 3 – Overview if Fall 2018 Consortium Activities: took consortium strategies only then put together when they can be done and divided them by goals. <ul style="list-style-type: none"> SWC k12 Student Success Pilot – Diane Atienza from SWWC identified program and limitations. Mapped out pilot of what types of workshops are helpful, will start in San Ysidro. A shared professional development calendar with conferences and webinars has been created. SWC will have access to enter professional development opportunities as well. The intent is to have each member share one calendar. Haven't decided how to share it. Work group kick- off event on September 14, 2018. On September 12, 2018 SUHSD Adult Education students will visit SWC for tour, followed by a NC 90 Class on October/November. Human Design Center class starts September 11 2018; it's a 4-6 weeks course. October - November 2018 – Have and advisory committee retreat, It's an opportunity to dismantle everything. Discuss allocations and member effectiveness. SWC adult learning community cohort for support services – will hopefully be established early October. Maybe have separate ESL cohorts. 20 – 25 students across all programs. Provide additional services to transition. • Agenda Item 4 – CUSD Curriculum Update: None. • Agenda Item 5 – SWC Curriculum Update: a series of Non Credit courses of how to be successful have been created but not launched yet. OSHA classes are ready to go, maybe they can be offered at the adult schools in the spring.

It's grant funded.• SWC HEC counselors and SUHSD Adult Ed counselors had an all-day retreat at SUHSD. Learned what everyone is doing. Counselors brainstormed and want more partnering with their region and more involvement in AEP.• We have ordered table cloths and a canopy with consortium logo for events. We would like consortium presence at community events.• Carol asked the group if the a Non Credit ESL transition specialist position could be funded by the consortium. She will put a document together and send it to the committee to explore further.
